# Thank you for your interest in Ephrata Youth Cheerleading Program. This packet outlines the Rules & Regulations that are followed by all Cheer Coaches and are expected to be followed by all cheerleading participants, parents, and guardians.

#### **Eligibility Requirements:**

- Student entering Kindergarten through 8<sup>th</sup> grade for the '25/26 school year
- Be in good standing with EYCP
- Complete all registration forms & waivers by deadline

#### **Communication:**

EYCP will be utilizing the **BAND** App for all communications. All schedules, due dates, fundraisers, and practice/game notifications will be posted in each Squads BAND group.

- BAND App is expected be checked prior to ALL practices & games for any last-minute updates and changes
- All Board members are part of every Squad BAND group and can be messaged directly via the app.

#### Program Costs & Fundraisers

#### **Registration Fee:**

- \$50/child (\$5 discount /each additional cheerleader if registering multiple participants)
- Due at time of registration and is a non-refundable fee
- Cash/Check/Credit Cards (additional services fees may apply) are accepted, returned checks have a \$35 fee and will be expected to pay the registration fee and return check fee with cash or credit card

#### **Program Fundraising/Events:**

The EYCP program will do year-round fundraising to help bring funds into the program. These fundraising events will continue to support the ability of financial costs to our EYCP families as low as possible. We ask that you share with friends, family and on social media to help make these events a HUGE success.

- 1. Mandatory Program Fundraiser—Domino's Pizza discount cards
  - a. Each cheerleader is required to sell 5 cards (\$10 each)
  - b. \$50 fundraiser deposit due to uniform fittings

#### Individual Cheerleader Fundraisers:

Each cheerleader is expected to participate in the fundraisers during the season. If you do not wish to participate, a \$25 opt-out fee will be available. The cheerleaders get a portion of profits from these fundraisers, and this can be applied directly to uniform costs or towards spirit wear store.

#### Practices & Games:

- Summer practices begin in July—Monday & Wednesday evenings 6-8 pm
- Fall practices (school in session)—Wednesday evenings 6-8 pm
  - o Will adjust end-times as needed
- Football games start in September, Labor Day Weekend is the first game
- Football games can be Saturday or Sunday
  - Last minute changes can happen, be sure to always check the communication app from coaches
- Kindergarten students, "Mini Mounts", will have modified practice & game obligations
- B & C Squad season can extend into November if they make the playoffs
- Attire:
  - Practices are outdoors- please dress appropriately
  - No jeans, jean shorts, crop tops or spaghetti straps
  - o Must wear sneaker
  - Hair should be pulled up
  - o No jewelry
  - Be sure to have enough water
    - Please no carbonated drinks—this attracts bees
- Please be sure your child uses the bathroom before practice/games.
  - If your child needs to use the bathroom at high frequencies, a parent/guardian may be asked to stay.
  - Coaches cannot stop practices/games for repeat bathroom trips

#### **Attendance Policy**

- 1. Attendance/Tardiness
  - a. Unapproved absence from practice or game, without prior notice.
    - i. Notice must be received by coach and board (via Band app) at least 2 hours prior to practice and/or game
    - ii. If notice is not received for a practice prior to a game, the cheerleader will not participate in the game or halftime routine, but will be required to attend the game, in full uniform.
    - iii. If notice is not received for a game, the cheerleader will not participate in the next game or halftime routine, but will be required to attend and fully participate in practice, as well as, being required to attend the next game in full uniform.
  - b. Sick for Practice or Game
    - i. Parent needs to notify coach and board (via Band app) at least 2 hours prior to practice and/or game
    - ii. If notice is not received, protocol and discipline is as stated in section a, above
    - iii. Cheerleader needs to be 24 hours fever free to return to practice/game
  - c. Vacation Time
    - i. Vacation calendar will be distributed at ice cream social and must be submitted to coach/board, no later than the first day of practice (July 7, 2025)
    - ii. Vacation requests will NOT be accepted after the game schedule comes out.
  - d. Practices and games are MANDATORY, all requests for time off must be submitted by July 7, 2025

#### **Behavior Expectations**

EYCP is committed to fostering a positive, respectful, and safe environment for all participants, coaches, and families. Cheerleading requires teamwork, discipline, and good sportsmanship. To maintain these standards, the following guidelines outline expectations for behavior and the steps taken if inappropriate behavior occurs.

#### **Expected Behavior**

All participants are expected to:

- Show respect to coaches, teammates, officials, and opponents.
- Use positive language and display good sportsmanship at all times.
- Follow instructions and attend practices and events on time.
- Maintain a positive attitude and encourage others.
- Care for equipment, uniforms, and facilities.

#### **Examples of Inappropriate Behavior**

Inappropriate behavior includes, but is not limited to:

- Disrespectful language, gestures, or actions toward others.
- Bullying, teasing, or excluding teammates.
- Physical aggression or unsafe conduct.
- Repeated tardiness or unexcused absences.
- Disregard for safety rules and coach instructions.

#### **Disciplinary Actions:**

The above Behavior Expectations are to be followed by all participants within the Ephrata Youth Cheerleading program. If they are not, the following steps will be taken:

- 1<sup>st</sup> Warning:
  - Verbal warning to cheerleader (parent/guardian will be notified).
- 2<sup>nd</sup> Warning:
  - Written warning sent home with cheerleader to be signed by parent/guardian. Cheerleader may not return to practice until the notice is signed and returned to the coach.
- 3<sup>rd</sup> Warning:
  - Meeting scheduled with cheerleader, parent, coach, and EYCP Board Member(s). The cheerleader will participate only at the coach/and or cheer board's discretion.
- 4<sup>th</sup> Warning:
  - $\circ$   $\;$  Dismissal from cheer squad for remainder of the season.

\*\*EYCP Board reserves the right to bypass any warning level or move for immediate dismissal of a cheerleader from the program if deemed necessary.
